Christmas party. Thank you to all who attended this fabulous event. As well as some great music and canapes, those in attendance at the Christmas party were also engaged by our guest speaker, Jenny Lawton, who spoke about the role and challenges faced by Bushfire Legal Help in the wake of the devastating February bushfires.

The newly elected Executive is extremely motivated about the year ahead, and we already have a number of events planned for the first quarter of next year including the Opening of the Legal Year Portia Laneway Breakfast (in collaboration with the Victoria Law Foundation), a seminar during Law Week, the Dame Roma Mitchell Memorial luncheon, and the Women's Achievement Awards.

The new Executive held its planning day on 5 December 2009, to consider what we want to achieve for our members, women in and outside of the law and the wider community. This strategic planning day is an important process and assists us to determine how to best direct our efforts and energy towards championing substantive equality for women.

I was recently reminded of the Listening Tour that Sex Discrimination Commissioner, Elizabeth Broderick, undertook at a national level in 2008. Commissioner Broderick's tour asked Australians: 'How far have we come in our journey towards gender equality? And where should we focus our efforts into the future?' It would be no surprise to VWL members that the Listening Tour revealed that gender inequality exists so pervasively in all elements of women's lives - in the workplace, in the home, in daily life. VWL is interested not only in gender equality, but in social justice more widely. Let's remember too that domestic violence can be exacerbated at Christmas time. The main victims, as we well know, are women and children.

This month we profile Sarah Birrell,
Senior Associate, Energy and Resources Group.

I became a lawyer because ... well, I really wanted to be a lion tamer, but thought the law might provide more career opportunities than lion taming. On a more serious note, I didn't have a very clear idea of what being a lawyer might involve when I started my studies. In hindsight, I became a lawyer because I thought it would be intellectually stimulating and challenging. And it is.

I am really proud of ... some of my most rewarding experiences have arisen from working as a volunteer lawyer for the Homeless Persons' Legal Clinic. In one matter, with a couple of other lawyers from Allens, we acted for a client who had over 150 fines, totalling around \$35,000. At the Magistrates' Court hearing, the Magistrate withdrew all of the fines on the grounds of the client's special circumstances.

You can have it all ... I am aspiring to this but haven't quite got there yet. However, if you have a flexible employer, then you are most of the way there.

I am extremely grateful for ... continuing on the theme of flexibility, the fact that Allens was flexible enough to allow me to take a couple of years off to travel

and to study a masters in law in London and then come back refreshed and ready for some interesting legal work.

A key mentor who influenced my career is ... there is no single person who has influenced my career. However, what I do enjoy about my job is that it gives me the opportunity to work with a variety of extremely capable partners and special counsel. As each person has their individual style, inevitably, you learn different things from each of them.

If I wasn't a lawyer ... and I didn't become a lion tamer, then I would like to be an explorer.

Before I started at Allens Arthur Robinson ... I spent a year working as a Judge's Associate in the Victorian Supreme Court, which was a fantastic experience, and then a year travelling with friends through China, Nepal, parts of Europe and the Middle East ... and Western Australia for some windsurfing.

The best advice I ever received was ... there's no need to live things twice . If you're nervous or apprehensive about something then don't spend all your time playing out the scenario in your mind before you actually need to do it.

One of the key legal initiatives I am involved in ... is helping with the development of Allens' climate change group, led by Grant Anderson. As you can imagine, introduction of the proposed Carbon Pollution Reduction Scheme has significant ramifications for many of our clients in the energy and resources sectors.

Outside of the law ... It's hard to choose between the mountains and the sea - I enjoy windsurfing, although my gear has been sitting in the shed gathering dust lately, and getting out into the hills for some bushwalking.
