WORD FROM THE CONVENOR

Dear Member,

I trust everyone is getting back into the swing of things after a relaxing holiday period. There have been many events happening to mark the commencement of the legal year, in both the religious and secular contexts. I hope you have been able to attend such an event to welcome in the legal year and reflect on the important role that each of us has in promoting justice, doing justice and being just.

I attended the International Commission of Jurists (ICJ) Community Observance for the opening of the legal year at Queen's Hall. The Governor, Professor David de Kretser asked the legal profession to think of the community we serve in carrying out our functions in pursuit of justice. The Hon Catherine Branson, the Australian Human Rights Commission President, encouraged us to prioritise the consideration of human rights in our work. David Toovey, the Former CEO of the Oaktree Foundation, encouraged the legal profession to open our hearts and to give. Community, human rights and giving are key elements of VWL's programme for the year ahead, and we hope we can encourage you to be part of this in any way you can. [New Law Reform Committee 2010](#)

VWL will increase its law reform activities in 2010 through the creation of a new law reform committee. This will enable VWL to further its objectives of working towards reform of the law and promoting understanding for women's legal and human rights. The new committee will take an active and coordinated approach

to law reform with a particular focus on:

- Access to justice;
- Human rights;
- Work related rights for women.

The committee will be led by Melanie Hodge, current co-chair of the Justice Committee.

Expressions of interest in being involved in the law reform committee are sought.

The committee will welcome members with expertise in any area or a general willingness to be involved. At this stage it is envisaged that the committee will meet on an ad hoc basis when law reform projects arise.

Women Migrants Legal Information Project (WMLIP) - Co-Chair opportunity

An exciting opportunity has arisen to co-chair a VWL committee, the Women Migrants Legal Information Project (WMLIP). This committee oversees the work of interns in scoping and preparing a series of publications aimed at informing vulnerable women migrants of their legal rights. The majority of work will be undertaken by interns and/ or a project officer.

The co-chair role would include organising meetings, checking interns' work, delegating tasks to committee members, and overseeing grant applications. The role is supported by one other co-chair and a committee of enthusiastic and experienced women who are passionate about women's rights and justice. The committee reports to and is further supported by the VWL Executive Committee. The role is voluntary and would require at least one hour per month for meetings. The work has already been supported by a Victoria Law Foundation grant.

VWL is seeking nominees with good organisational and communication skills and a keen interest in justice issues. Experience in migration law or issues would be helpful but is not essential. Co-chairs are also required to be VWL members. If you have always wanted to contribute to the community and assist vulnerable women migrants, this is an excellent opportunity to get involved with an achievable time commitment.
