Victorian Women Lawyers (VWL) Community Justice Award 2009

Do you know a law student or recently admitted practitioner who makes a significant community contribution through pro bono or volunteer work? If so, you can nominate them (or nominate yourself) for the 2009 Community Justice Award.

The Award is in recognition of a student or recently admitted lawyer who, on a pro bono or volunteer basis, demonstrates a commitment to issues related to women

and justice.

The successful nominee will receive a prize of \$1000, of which \$500 will be donated to their organization. The Award will be presented at the Women's Achievement Awards in September 2009.

VWL Pro Bono and Community Justice Forum

The VWL Pro Bono and Community Justice Forum took place at the Law Institute of Victoria on 21 May 2009. Three speakers presented to the audience about getting involved in community legal centres (CLCs) or pro bono work.

Marika Dias, principal solicitor of the Western Suburbs Legal Service, discussed the role of CLCs in the community, including the wide range of matters in which she acts from civil disputes to criminal matters to advising on anti-terrorism legislation. She also discussed the valuable role of CLCs in empowering communities by running targeted programs to educate people about their rights and responsibilities.

Mat Tinkler, Acting Executive Director of PILCH discussed the role of his organisation in the community, which is to provide access to pro bono assistance for thousands of community members, and the important legal and advocacy work of the Homeless Persons' Legal Clinic, Seniors Rights Victoria, and PILCH-Connect for the not-for-profit sector.

Belinda Lo brought an engaging and humorous personal perspective to the forum, confessing to her own "addiction" to volunteer work and highlighting some of the valuable insights that both volunteering and being employed in the community legal sector had provided her with.

The VWL Community Justice Award was also launched on the night. The Award is in recognition of a student or recently admitted lawyer who, on a pro bono or volunteer basis, demonstrates a commitment to issues related to women and justice. A student enrolled in a recognized bachelor of laws at a Victorian University, or a law graduate up to one year post admission to legal practice is eligible for the award. Candidates may be nominated by their organization or may self-nominate.

This month we profile Catherine Stuart, Senior Associate, Clayton Utz.

I became a lawyer because ... well, it seemed like an obvious choice after finishing my law degree (although I didn't really know at that stage what being a lawyer would actually involve). I think what is more important is that I decided to stick with it as a career. There are a number of reasons why I have continued being a lawyer but one of the most important for me is that it provides an opportunity for real teamwork. I know it sounds clichéd, but I do find genuine satisfaction in working towards and achieving goals with people that you enjoy working with.

I am really proud of ... the fact that I am part of a generation of women that have an opportunity to set an example for future generations in relation to career choices.

You can have it all ... but I think you need to make your own personal assessment of what "all" means to you.

I am extremely grateful for ... the opportunity to work and travel overseas for a couple of years (especially the couple of months I had eating my way around Italy!)

A key mentor who influenced my career is ... difficult to narrow down because I have had some fabulous mentors at Clayton Utz but I would single out Tricia Moloney and Dan Fitts as examples of excellent lawyers who are also extremely decent people.

If I wasn't a lawyer ... I would probably have finished some of the books gathering dust in a pile next to my bed! I suspect I might have become a teacher if I hadn't started down the lawyer path.

Before I started at Clayton Utz ... I was finishing my last year at university and having a pretty good time in the process.

The best advice I ever received was ... from my dad - there is no point being stressed about things you can't control (not actually that easy to follow in practice!)

One of the key legal initiatives I am involved in ... I couldn't really say that I am currently involved in any structured legal initiatives outside my day to day work. However, I do take seriously my role as a mentor for junior lawyers in our team. I remember feeling quite overwhelmed by the idea of working in a big law firm when I first started and I think it is very important to promote an open and supportive environment to give young lawyers the confidence to do the best job they can.

Outside of the law ... I play golf very badly and spend far too much time watching football on TV.
