White Ribbon Day Breakfast ñ 23 September 2009

VWL co-hosted the WRD breakfast with the LIV at the RACV club on 23 September 2009. White Ribbon Day supports the elimination of violence toward women by promoting cultural change. The event included a moderated discussion with Mary Louise Hatch from the Women's Legal Service Victoria, Ian Gray, the Chief Magistrate of Victoria and Fiona McLeod SC of the Victorian bar. The event

was well attended with 170 guests, many who asked cogent questions about the legislation that governs family violence.

VWL and Community Connections South West Community Legal Centre - Regional Sexual Assault Forum Warrnambool 21 August 2009

On 21 August 2009 VWL and Community Connections South West Community Legal Centre jointly hosted the 2009 regional sexual assault forum in Warrnambool. The event was kindly sponsored by Organisational Excellence Australia and South West TAFE. A wide variety of local professionals including solicitors, teachers, community workers, counsellors and other health care professionals attended the event.

The aim of the forum was to discuss issues affecting sexual assault victims including how victims may seek assistance and legal advice regarding a sexual assault. Discussion also focussed on sexual assault issues affecting the Indigenous community.

The forum consisted of three presentations and was facilitated by Juliet Williams of Community Connections. Of concern were the statistics obtained from the South Western Centre Against Sexual Assault which showed the prevalence of sexual assault amongst vulnerable groups such as children and persons with intellectual disabilities.

The services of the Aboriginal Family Violence Prevention and Legal Service were highlighted and include court support, legal representation and outreach services.

Munya Andrews, Victoria's only indigenous female barrister, gave a powerful presentation on the issues facing indigenous victims of sexual assault. She noted that fear of persecution, retaliation, abandonment and disownment from communities were serious issues affecting victims of sexual assault.

Protecting and Promoting Women's Rights: A Seminar for Lawyers and Barristers on Using the Optional Protocol to the UN Women's Convention

In December 2008, Australia became a party to the Optional Protocol to the Convention on the Elimination of All Forms of Discrimination against Women. This treaty establishes two procedures - a communication procedure and an inquiry

procedure ñ to enforce womenís rights to non-discrimination and equality.

This seminar will examine how the communication and inquiry procedures can be used to better protect and promote womenís rights, both domestically and internationally. It will explain how these procedures operate and provide detailed information on how to use them. The seminar will consider key jurisprudence decided under the Optional Protocol and reflect on lessons for advocates.
