Associate Professor Clare Wright

Winner of the 2014 Stella Prize

This event is supported by The Stella Prize, a major literary award celebrating Australian women's writing. The Stella Prize is committed to recognising the best books by Australian women, both fiction and nonfiction.

Associate Professor Clare Wright is a historian who has worked as an academic, political speechwriter, historical consultant and radio and television broadcaster. Clare's most recent book, *The Forgotten Rebels of Eureka*, won the 2014 Stella

Prize and the 2015 NIB Award for Literature and was shortlisted for the Prime Minister's Literary Awards, the NSW Premier's History Awards, the WA Premier's Literary Awards, the Victorian Community History Awards and the Queensland Literary Awards. She wrote and presented the ABC TV documentary *Utopia Girls: How Women Won the Vote* and co-wrote the ABC TV series *The War That Changed Us*. She is currently a Principal Research Fellow in History at La Trobe University.

Clare's address will discuss the history and legacy of women's political activism in Australia. Clare will introduce us to some of the extraordinary women who have struggled for democratic reforms that we now see as central to our civic liberty.
